### I. Welcome and Introductions

Dr. Scherrer began the meeting at 9:33, the agenda was reviewed and everyone in the group introduced themselves.

### II. Purpose of SPLC and Format for 2019-2020

The Purpose of SPLC was discussed. Dr. Scherrer explained the importance of completing the topics Google form. He asked everyone to have it completed by the end of the day September 20. He stated that it helps identify hot topics and keeps everyone in the loop. He stated that the 9:30a.m. to 11:00 a.m. timeframe would be adhered to this year.

The role of the School Board was presented and their photos were shared.

### III. Back to School Overview

The District Mission and Vision were presented and explained. Dr. Scherrer also discussed the Comprehensive Plan and how NA measures success. He reviewed FOCUS 2020, stating it is in its fifth year. He discussed the Program review that was conducted last year, and shared the recommendations that came from that review. The District is focused on creating a modern learning environment by implementing the Digital Convergence Framework.

Dr. Scherrer reported that third day enrollment is up 60 more students than last year; however, there are 133 more elementary students than last year. The Franklin expansion project was discussed, which led into a review of the Redistricting Plan. Dr. Scherrer explained the measures taken by the District to survey families, staff, and students for input on their most important issues regarding redistricting. He stated that results would be analyzed and only one scenario will be presented for Board approval on September 25.

IV. Redistricting Update

Redistricting processes and procedures were discussed. More information will be presented at the September 25, 2019, Board Meeting being held at A.W. Beattie.

V. Website Redesign and Back to School Publications

Mr. Walker and Ms. Schafer discussed a possible new website design and requested feedback regarding the revised back to school publications. The majority agreed that the publications were better this year. They also expressed appreciation for the new weekly email.
