- I. Welcome and Agenda Review  
Dr. Bradley began the meeting and introduced Dr. O'Toole. Dr. O'Toole reviewed the agenda items and introduced Dr. Sciallo to discuss COVID-19 Update.
- II. COVID-19 Update  
Dr. Sciallo shared the NASD COVID-19 Tracker that is posted on the District website. He discussed the Cases in a Rolling 14-Day Span and stated that the District recently moved from Substantial Spread to Moderate Spread. Dr. Friez shared the transition plans and timeline for returning high school students to full in-person instruction.
- III. 2021-2022 School Calendar  
Dr. Friez reviewed the 2021-2022 School Calendar and answered questions regarding snow days and FIDs days.
- IV. Planning for 2021-2022  
Dr. Friez shared the planning timeline for the 2021-2022 school year. She explained what groups would comprise the committee in which feedback would be collected for decision-making. Dr. Friez reported that families will be surveyed several times to determine enrollment preference, and she indicated that the School Climate Survey would be conducted in April 2021. She also noted that nominations will be accepted until March 1, 2021, from those wishing to be part of the planning group.

V. Redistricting Information

Dr. Bradley provided an update on the Redistricting Plan that was postponed due to the pandemic and will be implemented at the start of the 2021-2022 school year. He shared past and current enrollment numbers and discussed the current challenges. Dr. Bradley discussed the expansion of Franklin Elementary and renovations to McKnight Elementary that allow for more sections at each grade level. Dr. Bradley also discussed the Continuation Option and transition activities.

Mr. Sechler shared school boundary maps showing the revised boundaries.

VI. Securly Update

Mr. Platts explained the function of Securly and how the District uses the information gathered. He also provided an update on what is new in Securly 24 and how the District handles student safety issues.

The next scheduled virtual SPLC meeting is March 11, 2021.
